3. Sealed Quotation Forms may be purchased from the address below by eligible Suppliers on the submission of a written application and upon payment of a non-refundable fee of *Rs.300.00* within the office hours up to 15th day of the first publication, i.e., 4 June, 2016 (22-02-2073).
4. Sealed Quotations must be submitted to the address below at or before 12:00 hrs of 16th day of the first publication i.e. 5 June, 2016(23-02-2073). Quotations shall be in a sealed envelope addressed to the address below indicating name of the contract, contract identification number, supplier's name and address. Quotation received after this deadline shall not be accepted.
5. Quotations shall be opened in the presence of the suppliers' representatives who choose to attend in person at the address below at 13:00 hrs on 16th day of the first publication i.e., 5 June 2016(23-02-2073) at chure office, khumaltar.
6. Quotations must be valid for a period of 45 days after opening of Sealed Quotation and must be accompanied by Bank Guarantee, amounting NRs. 30,000 which shall be valid upto September 1, 2016. (16-05-2073)
7. All bids must be accompanied by a Bid Security of amount as specified in above. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in *Dharauti* Account no 135001 , Office Code No 2732923 in the name of Treasury Controller Office, Singha Durbar Everest Bank and should submit the original receipt of the deposited amount of cash along with the Bid. Bid Security should be valid for up to 30 days beyond the bid validity period. i.e up to September 1, 2016 (16-05-2073)
